#### **Latest News & Updates from Iowa Total Care**

- Member appeals for National Imaging Services (NIA) to be completed by ITC beginning August 1, 2020.
- ITC to conduct medical record audits to monitor age-appropriate behavioral health and substance abuse screenings during child preventive well visits.
- The Choose Wisely campaign is an initiative to promote a national dialogue between clinicians and patients to avoid unnecessary medical tests, treatments and procedures. <u>A link to this program and its resources</u> is now available on the ITC website.
- The Universal Prior Authorization (PA) Forms will be on the ITC website
  by the end of July. It is still permissible to use the old PA forms through
  September 30, 2020. Beginning October 1, 2020, ITC will only accept the
  new medical PA forms.
